While filing your income (ITR) for assessment 2018-19, the deadline is 31 July, don't just file Form 16 you get from your employer even if you are a salaried employee. Make sure you disclose gains or losses from selling shares or redeeming (MF) units, or selling a property.

Irrespective of the amount of gains, one must disclose capital gains while filing ITR. Here is how you can calculate gains from different assets and disclose them while filing ITR.

CALCULATING CAPITAL GAINS

Profits or gains arising from the sale of capital asset such as shares and bonds are called capital gains and taxed under the head "capital gains". There are two types—short-term and long-term capital gains, depending on the period of holding. Capital gains are calculated by deducting the cost of the asset from its sale price. They are different for different asset classes.

Real estate
Transfer of immovable property such as house, apartment, plot, etc. are covered under (STCG); after deducting capital gain tax, the remaining amount is indexed.

To calculate the cost of acquisition, the year of purchase is taken as the base year. The cost is indexed by a chart published by the government.

HOW TO FILE ITR
If you have sold shares, MF units, or real estate, you need to file ITR. The deadline is 31 July. You can file ITR online through the Income Tax e-filing portal or through a Chartered Accountant. You need to attach Form 16 from your employer and Form 10B from the Mutual Fund.
