Members are informed that: 1) The e-voting period commences on Monday, August 31, 2015 (9.00 am IST) and ends on Wednesday, September 02, 2015 (5:00 pm IST). The remote e-voting will not be allowed beyond the aforesaid date and time and the e-voting module shall be disabled by CDSL upon expiry of aforesaid period. 2) A person whose name is recorded in the register of members or in register of beneficial owners maintained by the depositories as on the cutoff date i.e. Thursday, August 27, 2015 only shall be entitled to cast their vote by e- voting as well as voting at AGM through poll. 3) Members who have not cast their votes by e-voting may cast their votes at the AGM venue by way of poll. 4) A member may attend the AGM even after exercising his right to vote through e-voting, but shall not be eligible to vote at AGM. 5) Any person, who acquires shares of the Company and becomes the member of the Company after despatch of the Notice of the meeting and holding shares as of the cut-off date i.e. Thursday, August 27, 2015, may follow the same procedure as mentioned in the Notice of AGM for remote e-voting or may write to Link Intime on the e-mail id delhi@linkintime.co.in for obtaining log-in id & password. However, if such shareholder is already registered with CDSL for remote e-voting then existing user id and password can be used for casting the vote. 6) Mr. Rupesh Agarwal, Chandrasekaran Associates, Company Secretaries, (Membership No. ACS 16302) has been appointed as the Scrutinizer to scrutinize the remote e-voting/poll process in a fair and transparent manner. 7) The results of voting on the resolutions set out in the Notice of the AGM shall be declared not later than forty eight (48) hours of conclusion of AGM.
