This is in continuation of our intimation dated August 14, 2023 wherein in Annexure-A pertaining to "GST dues" at Clause (a), the Company had reported writ petition filed before Hon'ble Delhi High Court against impugned order of National Anti-Profiteering Authority amounting to Rs. 41.43 crores. In this regard, please find below further update on the said matter in the format prescribed under Regulation 30 of the Listing Regulations read with SEBI Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023.

The details of any change in the status and / or any development in relation to such proceedings	<p>Hon'ble Delhi High Court has upheld the validity of Section 171 of the CGST Act &amp; rules made thereunder vide order dated January 29, 2024.</p> <p>The Court clarified that it is possible that there may be cases of arbitrary exercise of power under the anti-profiteering mechanism by enlarging the scope of the proceedings beyond the jurisdiction or on account of not considering the genuine basis of variations in other factors such as cost escalations on account of which the reduction stands offset, skewed input credit situations etc. Matter is now listed before Delhi High Court Division Bench-I on February 8, 2024 for issuing appropriate directions.</p> <p>The Company would wait for directions of the Hon'ble Delhi High Court Division Bench -1 before taking appropriate action.</p> <p>The Company has a strong case on merits and the stay granted earlier continues in this matter.</p>
