भारत सरकार, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय द्वारा जारी ई.आई.ए. नोटिफिकेशन, 2006 (यथा-संशोधित) के तहत सर्व संबंधित को सूचित किया जाता है कि मेसर्स अल्ट्राटेक सीमेंट लिमिटेड (यूनिट ऑफ रावन सीमेंट वर्क्स), ग्राम-रावन, तहसील-सिमगा, जिला-बलौदाबाजार-भाटापारा (छ.ग.) द्वारा क्षमाता विस्तार के तहत क्लिंकर - 6.5 मिलियन टन प्रतिवर्ष से 10.0 मिलियन टन प्रतिवर्ष, सीमेंट- 3.3 मिलियन टन प्रतिवर्ष से 7.0 मिलियन टन प्रतिवर्ष, डब्ल्यूएचआरएस - 16 मेगावाट से 36 मेगावाट एवं केप्टिव पावर प्लांट - 80 मेगावाट के लिये पर्यावरणीय स्वीकृति हेतु लोक सुनवाई बावत छ.ग. पर्यावरण संरक्षण मंडल में आवेदन किया गया है। उक्त परियोजना के संबंध में आपत्ति/सुझाव/विचार/टीका टिप्पणी, इस सूचना के जारी होने के दिनांक से 30 दिवस के अंदर क्षेत्रीय अधिकारी, छत्तीसगढ़ पर्यावरण संरक्षण मंडल, व्यवसायिक परिसर, कबीर नगर, रायपुर के कार्यालय में मौखिक अथवा लिखित रूप से कार्यालयीन समय में प्रस्तुत की जा सकती है। इस परियोजना के लिए लोक सुनवाई दिनांक 16/12/2020 दिन बुधवार समय 11:00 बजे से स्थल- तहसील पलारी अंतर्गत ग्राम- सरसेनी के पानी टंकी के सामने मैदान पर नियत की गई है। यह भी सूचित हो कि :-

1. लोक सुनवाई के दौरान सम्मिलित होने वाले व्यक्तियों को फिजिकल/सोशल डिस्टेंसिंग का पालन करना अनिवार्य होगा।
2. लोक सुनवाई में सम्मिलित होने वाले व्यक्तियों द्वारा मास्क का उपयोग किया जावेगा तथा समय-समय पर सेनेटाइजर का उपयोग किया जाना अनिवार्य होगा।
3. लोक सुनवाई स्थल पर सम्मिलित होने वाले व्यक्तियों को बैटक व्यवस्था कम से कम 02 मीटर की दूरी रखना अनिवार्य होगा।
4. कोरोना वायरस के निरोधक एवं रोकथाम हेतु शासन द्वारा जारी समस्त दिशा-निर्देशों का अक्षरशः पालन किया जाना अनिवार्य होगा।

NOTES:

1. These unaudited financial results have been prepared in accordance with the recognition and measurement principles as laid down in the Indian Accounting Standards (referred to as "Ind AS") prescribed under Section 133 of the Companies Act, 2013 read with Companies (Indian Accounting Standards) Rules as amended from time to time. The above standalone and consolidated unaudited financial results were reviewed by the Audit Committee and approved by the Board of Directors of the Company at their meetings held on 12th November 2020. The statutory auditor's report on review of interim standalone and consolidated unaudited financial results for the quarter and six months ended 30th September 2020 is being filed with the BSE Limited and National Stock Exchange of India Limited.
2. During the current periods, consequential to COVID-19 pandemic the Company has negotiated several rent concessions. In view of recent amendments by the Companies (Indian Accounting Standards) Amendment Rules, 2020, the Company has elected, as a practical expedient, not to assess these rent concessions as lease modifications and has recognized impact of such rent concession in Statement of Profit and Loss. The election is made for all such rent concessions as these satisfy the conditions mentioned in Para 46A and Para 46B of Ind AS 116 (as amended). According during the quarter ended 30th September 2020, 30th June 2020 and six months ended 30th September 2020 an amount of INR 1,611.61 lakhs, INR 2,943.35 Lakhs and INR 4,554.96 lakhs respectively related to rent concessions has been reduced from Rent expense included under Other expenses. After adjusting the rent expense for the quarter ended 30th September 2020, 30th June 2020 and six months ended 30th September 2020 amounting to INR 1,885.06 lakhs, INR 908.28 Lakhs and INR 2,793.34 lakhs respectively, the net rent expense/ (income) accounted in Other expenses for quarter ended 30th September 2020, 30th June 2020 and six months ended 30th September 2020 is INR 273.45 lakhs, INR (2,035.07) lakhs and INR (1,761.62) lakhs respectively. (In consolidated unaudited financial results during the quarter ended 30th September 2020, 30th June 2020 and six months ended 30th September 2020 an amount of INR 1,616.26 lakhs, INR 2,965.80 lakhs and INR 4,582.06 lakhs respectively related to rent concessions has been reduced from Rent expense included under Other expenses. After adjusting the rent expense for the quarter ended 30th September 2020, 30th June 2020 and six months ended 30th September 2020 amounting to INR 1,906.48 lakhs, INR 935.64 Lakhs and INR 2,842.12 lakhs respectively, the net rent expense/ (income) accounted in Other expenses for quarter ended 30th September 2020, 30th June 2020 and six months ended 30th September 2020 is INR 290.22 lakhs, INR (2,030.16) lakhs and INR (1,739.94) lakhs respectively).
3. The Company's business activity falls within a single business segment i.e. Food and Beverages in terms of Ind AS 108 on Segment Reporting.
4. The Company decided to close 105 stores during the quarter ended 30th September 2020 (9 stores closed during the quarter ended 30th June 2020) and accordingly the effect of closure on property, plant and equipment by way of accelerated depreciation and de-recognition of Right of use assets and related lease liabilities have been considered in the financial results. The impact for quarter and six months ended 30th September 2020 on this account is INR 1,674.86 lakhs and INR 1,962.48 lakhs respectively included in Depreciation and Amortisation expense and INR 2,037.67 lakhs and INR 2,088.77 lakhs respectively included in Other Income (net) towards de-recognition of Right-of-use assets and lease liabilities.
5. The COVID-19 situation across the country affected the normal dine-in operations of the restaurants resulting in lower sales. However, the Company has taken various measures to protect profit margins. The Company has made detailed assessments of its liquidity position for the next one year and of the recoverability and carrying values of all its assets and liabilities as at 30th September 2020 and on the basis of evaluation based on the current estimates has concluded that no material adjustments is required in the financial results. Given the uncertainties associated with nature, condition and duration of COVID-19, the impact assessment on the Company's financial statements will be continuously made and provided for as required.
6.
